4. After receiving the materials, the Organizing Committee sends a confirmation letter to the participant within two days.

5. A participant may submit only one report that has not previously been published. (Including co-authorship).

6. The maximum number of authors is three (including the supervisor).

7. A summary of the conference materials will be published as a result of the conference.

REQUIREMENTS FOR ABSTRACTS

1. The volume of abstracts - up to 3 pages that are not numbered.
2. Font - Times New Roman, size - 14, line spacing - 1.5, paragraph - 1 cm, size of all margins 20 mm.
3. The use of illustrative materials in abstracts should be minimal. The font size in the table is 12, the header is 14.
4. The format of tables and figures should be in book form only.
5. The author and the scientific supervisor are responsible for the content and design.

The sequence of materials in the abstract of the report:

- JEL (in the upper left corner) 12 font;
- title of the abstract (capital letters, boldface);
- surname and initials of the author (no more than two);
- name of educational institution;
- text;
- the list of used literature should be designed in accordance with the requirements used for the design of scientific works. References to the sources must be indicated in square brackets by the serial number of this work in the list of sources used.
